Call to Order

Kenneth "Ed" Campbell called the meeting to order. Michael Jeter was absent. All other board members were present. Alvin Lum & Joe Ethredge are new board members

Prayer / Pledge

Ronnie Land led the prayer, Kenneth "Ed" Campbell led the pledge.

Open floor discussion

Teresa spoke about retiring early due to problems with the current administration. She will retire on April 30, 2025. Randy stated that all employees can come and talk to any board member at any time without David being present. David stated that he did not state that the employees could not talk to a board member without him being present.

Approval of Minutes of February 2025 meeting

Water System Update

Administrative Report

Replaced a connection with the City of Mansfield at the plant site. Reciprocating fees because neither system could find a list of what water charges would be. Both systems will keep a list of the amount of water either company uses. Tim talks and shows a slide presentation regarding ammonia, chlorine and chloramines. Waterworks has to have ammonia injected into the system at the plant and all tank sites. The board gave Josh permission to work overtime to get all the tank sites prepared. States that it could take appx. 1 week to do each tank site.
