Totes were given to us by the Town of Blanchard. We will have to have 5 chemical pumps at \$1,200 - \$1,500 each. Will have to take samples every day once we get it all set up. Donnie Fisher states that if Angela is trainable then she should be the one to do the samples since she is doing daily sampling. Need to get safety equipment. We may need to hire at least one more person. We need to set a clothing allowance.
